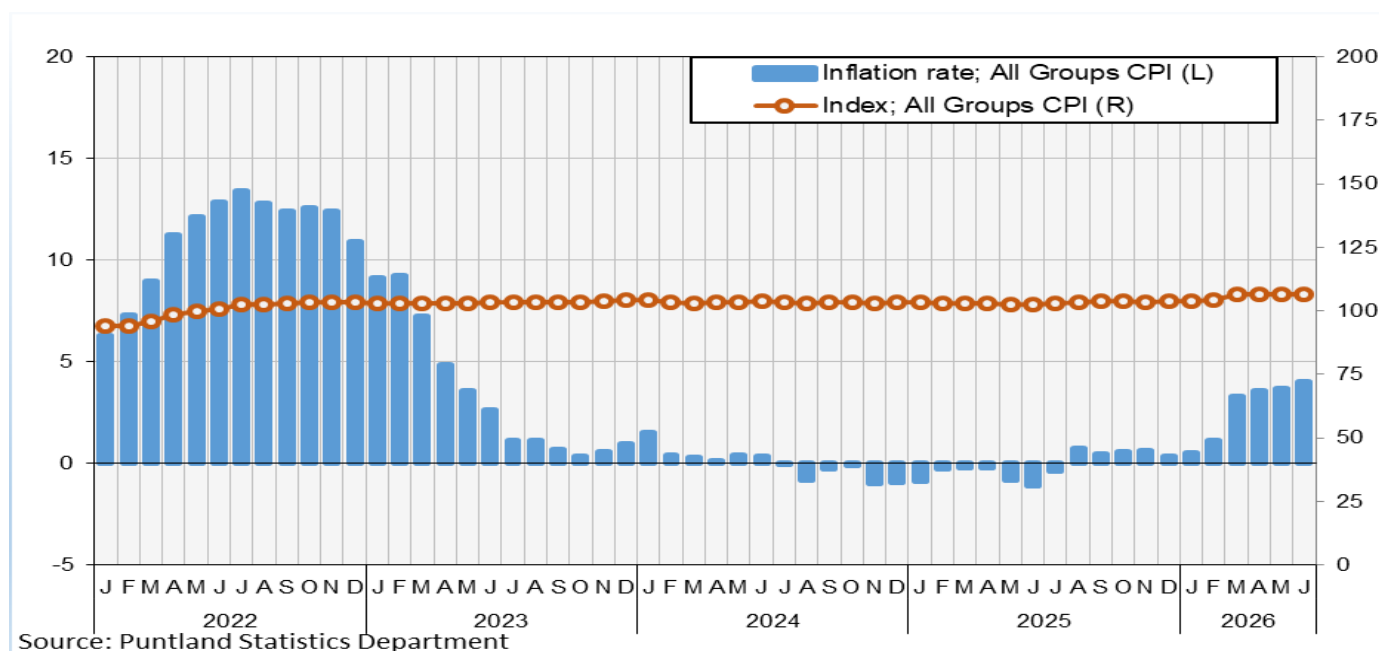
Consumer Price Index June 2026

Consumer Price Index: All Groups CPI, June 2026.

Puntland basket of consumer goods and services sample contains 12 categories based on the standard classification of individual consumption by purpose. These 12 categories consist of 387 individual items of goods and services, and the price per item is collected from the markets of all the major cities in Puntland on weekly basis.

The All-Groups CPI increased from 106.46 to 106.68 in June 2026. The monthly change in June 2026 was an increase of 0.21 percent compared to decrease of -0.21 percent in the previous month of May 2026. The most significant monthly price increases were Clothing & Footwear (0.49%) and Food & Beverages (0.46%). This Positive movement led to a price decrease at the All-Groups CPI level.

The annual change (or inflation rate) over the twelve months to June 2026 was an increase of 3.99 percent. This change is compared to an increase of 3.66 percent over the twelve months to May 2026. The most significant price increase was Miscellaneous Goods & Services (11.12%), Transport (6.07%), Food & Beverages (5.41%), Housing, Water, Electricity, Gas (3.81%) and Clothing & Footwear (3.37%). In general, there has been a well-grounded positive price development.

Consumer Price Index: Selected Groups in June 2026.

Food & Beverages and Housing, Water, Electricity, Gas, and Other Fuels are currently the most significant items in the consumer basket regarding household expenditure and therefore have the largest weighted influence on the All-Groups CPI.

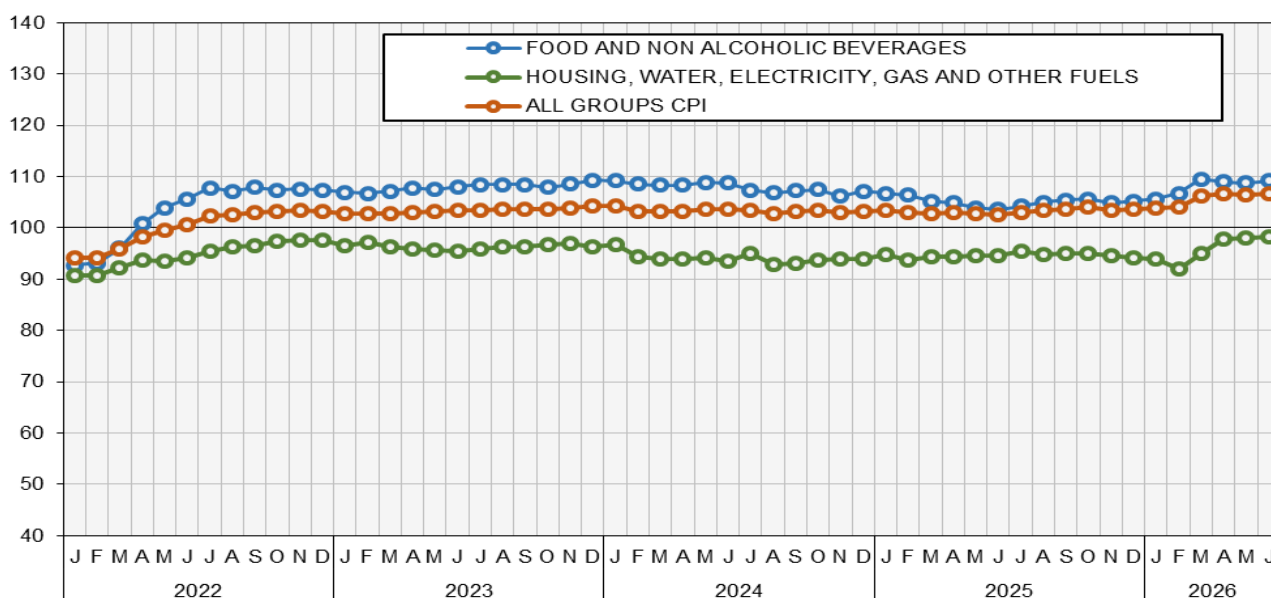
Food & Beverages experienced a monthly increase of 0.46 percent in June 2026, compared to a price decrease of -0.27 percent recorded in May 2026. Year-on-year inflation increased by 5.41 percent in June 2026; this change is compared to the year-on-year inflation of 4.59 percent increase experienced in May 2026.

Housing, Water, Electricity, Gas, and Other Fuels experienced a monthly increase of 0.08 percent in June 2026 compared to a price increase of 0.35 percent recorded in May 2026. The year-on-year inflation rate increased by 3.81 percent in June 2026; this change is compared to year-on-year inflation increase of 3.83 percent experienced in May 2026.

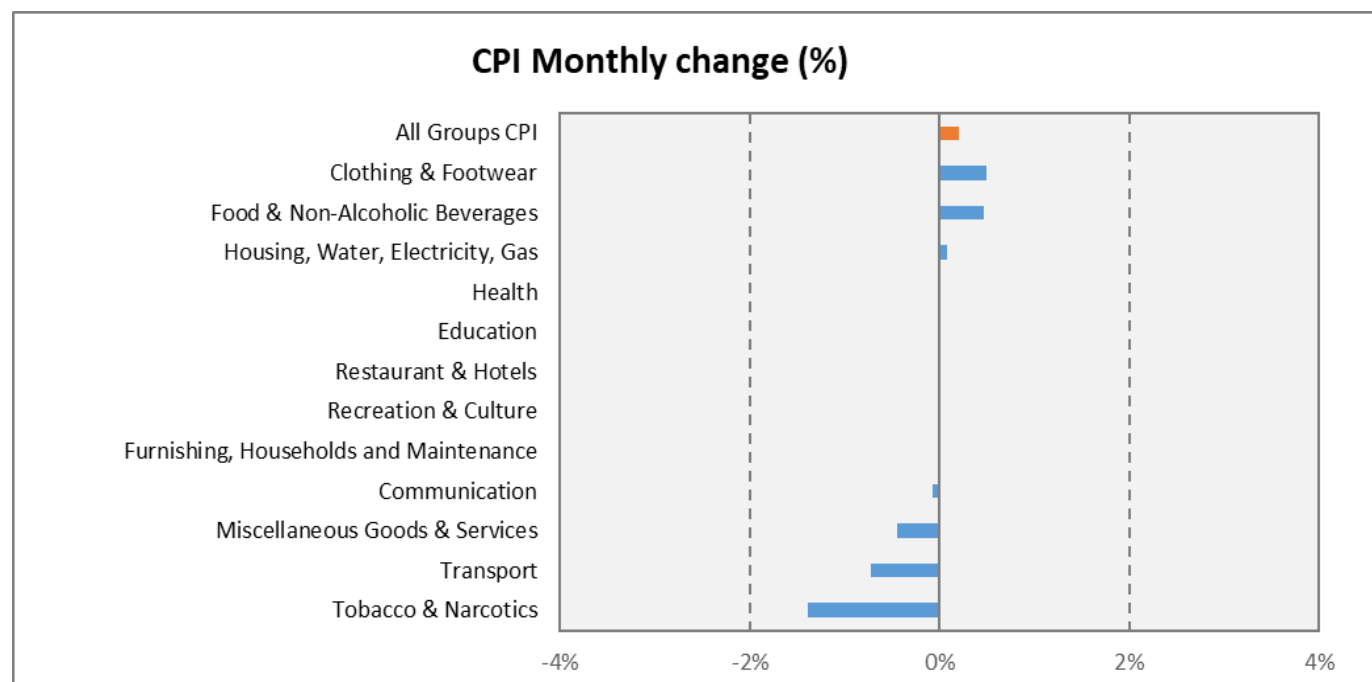
Figure 2: All Groups CPI comparison with selected groups.

Consumer Price Index: Major Movements by COICOP Group – Monthly Change

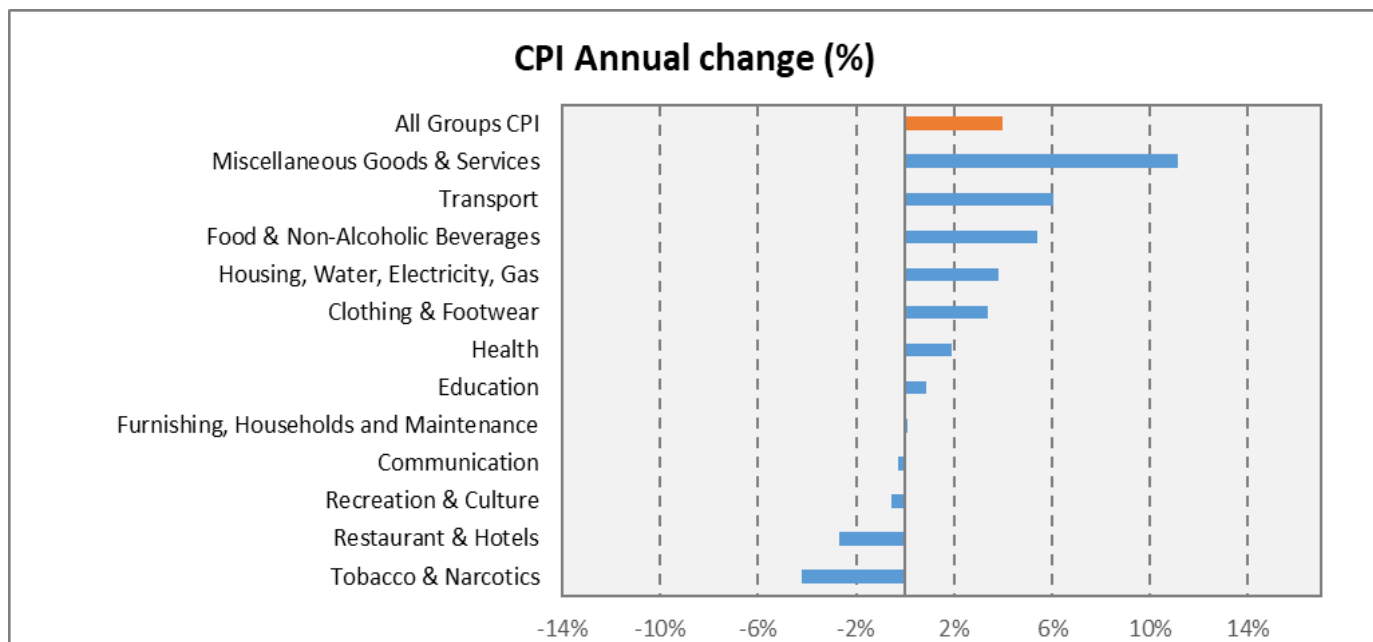
Figure 3: CPI indices, monthly inflation rate by COICOP groups; June 2026.



- **Major contributors (Positive).**
- **Food and non alcoholic beverages** prices increased by (0.46%) in June 2026 compared to a price of (-0.27%) in May 2026. This increase was mainly attributed to Food (0.49%).
- **Clothing & Footwear** prices increased by (0.49%) in June 2026 compared to a price of (-0.42%) in May 2026. This increase was mainly attributed to clothing (0.63%).
- **Major contributors (Negative).**
- **Tobacco and Khat** prices decreased by (-1.39%) in June 2026 compared to a price of (-0.39%) in May 2026. This decrease was mainly attributed to tobacco (-2.61%).

Major contributors (positive).

- **Miscellaneous goods and services** category showed an annual price development of (11.12%) for the year ending in June 2026, compared to an increase of (12.20%) recorded for the year ending in May 2026. This was mainly due to personal effect (36.01%).
- **Transport** category showed an annual price development of (6.07%) for the year ending in June 2026, compared to an increase of (6.82%) recorded for the year ending May 2026. This was mainly due to Operation of personal transport equipment (8.96%) and transport services (5.93%).
- **Food & Beverages** category showed an annual price development of (5.41%) for the year ending in June 2026, compared to an increase of (4.59%) recorded for the year ending May 2026. This was mainly due to food (5.68%).
- **Housing, water, electricity, gas and other fuels** category showed an annual price development of (3.81%) for the year ending in May 2026, compared to an increase of (3.83%) recorded for the year ending May 2026. This was mainly due to Maintenance and repair of the dwelling (9.74%) and electricity, gas and other fuels (3.64%).

Major contributors (Negative).

- **Tobacco & Khat** showed a negative annual price development of (-4.22%) for the year ending in June 2026, compared to a decrease of (-4.07%) recorded for the year ending May 2026. This was mainly due to tobacco (-6.19%).

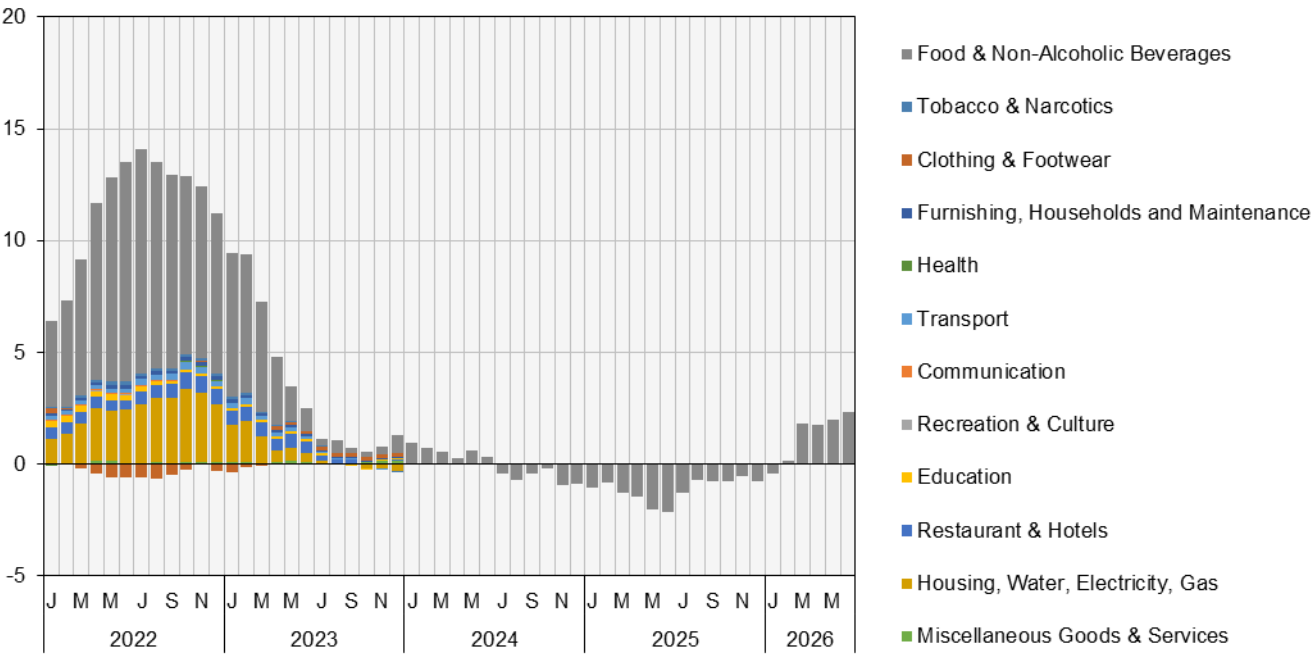

Figure 5 provides an additional analysis of the All-Groups CPI inflation result. The All-Groups movement is broken into a cross-section of COICOP Groups displaying their respective impact (contribution) to the All.
